15-Day Notice of Modifications to Text of Proposed Regulations

New Flammability Standards for Upholstered Furniture / Articles Exempt from Flammability Standards

Pursuant to the requirements of Government Code section 11346.8(c), and California Code of Regulations, Title 1, Section 44, the California Bureau of Electronic and Appliance Repair, Home Furnishings and Thermal Insulation (Bureau) is providing notice of changes made to the above entitled proposed regulation. Specifically, the Bureau is making changes to the text of Sections 1126, 1370, 1373.2, 1374, 1374.2, and 1383.2 of Title 4 of the California Code of Regulations. The Bureau is also making changes to the Technical Bulletin 117-2013 (TB 117-2013) which is to be incorporated by reference under Section 1373.2.

Modifications to the proposed language:

The Bureau is modifying Sections 1126(11) and (12) by updating the standard's reference date from January 2013 to June 2013 to reflect its revision date.

The Bureau is repealing Section 1370(a) to remove misleading and duplicative regulatory language.

The Bureau is modifying Section 1373.2 and 1374(a) by extending the manufacturers' mandatory compliance date from "On or after July 1, 2014" to "On or after January 1, 2015" to allow the additional time needed to deplete current supplies and effectuate the new regulatory changes; by deleting "test" and adding "fire retardant" to add clarity to the requirements of these sections; and by updating the standard's reference date from January 2013 to June 2013.

The Bureau is modifying Section 1373.2 to add language which would incorporate by reference the Technical Bulletin 117-2013 into regulation.

The Bureau is modifying Section 1374(a) by adding language which would provide reference to specific labeling requirements.

The Bureau is deleting infant mattresses and infant mattress pads from the criteria of exemption in Section 1374.2(c) since these products are currently under the jurisdiction of the Consumer Product Safety Commission and not the Bureau.

The Bureau is adding subsection (d) to Section 1374.2 which would allow articles of upholstered furniture to be manufactured in accordance with a written prescription from certain health care professionals, or with other comparable written medical therapeutic specification, that would be exempt from having to meet flammability standards. In addition, the Bureau is defining "health care professional" to make clear who would be qualified to write a prescription that would be considered valid and acceptable.

The Bureau is modifying Section 1383.2 by deleting the citation and fine provision of subsection 1370 to provide consistency with the repeal of Section 1370.

Modifications to the TB 117-2013 Standard:

Introduction:

• This section was modified to add reference to the decking materials test method.

1.Scope:

- Subsection 1.3 was modified to add reference to the decking materials test method.
- Subsection 1.4.4 was added to include the definition of the term "Decking Material Test"

2.Referenced Documents:

- Subsection 2.1 was modified to name the correct version of the ASTM standard which is to be referenced. This grammatical correction changed "ASTM E1353-08a" to "ASTM E1353-08a^{ε1}".
- Subsection 2.3 was added to include the document AATCC Test Method 124-2011 as a reference.

3.Terminology:

- Subsection 3.3 was modified to clarify the meaning of the term "Barrier (interliner) material".
- Subsection 3.5 was added to include the term and definition of "Deck" under this section.

4.Summary of Test Method:

• This section was modified to add reference to the decking materials test method.

Section 1. Cover Fabric Test

1.2 Test Specimen:

- The initial instruction was modified to name the correct version of the ASTM standard which is to be referenced which is "ASTM E1353-08a^{ε1}".
- 1.3 Test Procedure:
- The initial instruction was modified to name the correct version of the ASTM standard which is to be referenced which is "ASTM E1353-08a^{ε1}".
- Step 1.3.1 was deleted to remove the reference to the draft enclosure from the standard.
- Step 1.3.2 was renumbered to Step 1.3.1. The typographical error relating to the measurement between test specimens was corrected from 125 mm to 152 mm throughout the standard. In addition, the measurements were reordered to read inches/mm instead of mm/inches for consistency throughout the standard.
- Step 1.3.3 was renumbered to Step 1.3.2.
- Step 1.3.4 was deleted to remove the requirement that the maximum char length is to be measured in all directions. Instead ASTM step 11.9 is to be followed in its entirety which requires the char length to be measured in a vertical direction.

1.4 Pass/Fail Criteria:

• Step 1(b) was modified to make specific that the pass or fail of test specimen would be determined by measuring the vertical char length instead of measuring the char length in any direction.

Section 2. Barrier Materials Test

2.2 Test Specimens:

- The initial instruction referencing ASTM Section 20 was deleted to allow for modification to the measurements of the test materials.
- Step 2.2.1 was modified to make clear that the measurements of the test material mentioned in TB 117-2013 differed from that mentioned in ASTM step 20.1.
- Step 2.2.2 was added to make clear that the measurement of the Standard Type II cover fabric mentioned in TB 117-2013 differed from that mentioned in ASTM step 20.2.

2.3 Test Procedures:

- New step 2.3.1 (same as ASTM step 21.1) was added for easier to follow directions.
- New step 2.3.2 was added to make clear that the measurement of the cover fabric mentioned in TB 117-2013 differed from that mentioned in ASTM step 21.2.
- The instruction was modified to name the correct version of the ASTM standard which is "ASTM E1353-08a^{ε1}". The instruction was also modified to clarify that the ASTM test procedures are to be followed beginning with step 21.3 rather than step 21.1.
- The former step 2.3.1 was deleted to remove the reference to the draft enclosure from the standard.
- The former step 2.3.2 was renumbered to 2.3.3. The typographical errors and reorder of the measurements were corrected as mentioned above in step 1.3.2.
- The former step 2.3.3 was renumbered to Step 2.3.4.
- Step 2.3.4 was deleted to remove the requirement that the maximum char length is to be measured in all directions. Instead ASTM step 21.9 is to be followed in its entirety which requires the char length to be measured in a vertical direction.

2.4 Pass/Fail Criteria:

- Step 1(b) was modified to make specific that the pass or fail of test specimen would be determined by measuring the vertical char length instead of measuring in any direction.
- Step 5 was added back into the Pass/Fail Criteria as the correct numbering of the section was deleted in error.

Section 3. Resilient Filling Material Test

3.2 Weighing Device:

• Subsection 3.2 was deleted to remove the reference to the weighing device from the standard.

3.3 Test Specimen:

- 3.3 Test Specimen was renumbered to 3.2 Test Specimen
- The initial instruction was modified to name the correct version of the ASTM standard which is "ASTM E1353-08a^{ε1}".
- Step 3.3.1 was renumbered to 3.2.1.
- Step 3.3.2 was renumbered to 3.2.2.
- Step 3.3.3 was renumbered to 3.2.3. Also, the typographical errors relating to the measurement of the filling material thickness was corrected from 1.27 mm to 12.7 mm.

- Step 3.3.4 was deleted to remove the requirement relating to the weighing and recording of the test specimen.
- A note was added to specify how to measure and read the thickness of the test materials.

3.4 Test Procedure:

- 3.4 Test Procedure was renumbered to 3.3 Test Procedure.
- The initial instruction was modified to name the correct version of the ASTM standard which is "ASTM E1353-08a^{ε1}".
- Step 3.4.1 was deleted to remove the reference to the draft enclosure from the standard.
- Step 3.4.2 was renumbered to 3.3.1. The typographical errors and reorder of the measurements were corrected as mentioned above in step 1.3.2.
- Step 3.4.3 was renumbered to 3.3.2 and "ASTM E1353-08a" was modified to "ASTM E1353-08a^{ε1}" to correct the version of the ASTM standard referenced in this section.
- Step 3.4.4 was renumbered to 3.3.3.
- Step 3.4.5 was renumbered to 3.3.4.
- Steps 3.4.6 and 3.4.7 were deleted as the pass/fail criteria will no longer be determined based on the percentage of mass loss but by the maximum char length.

3.4 Pass/Fail Criteria:

- Step 1 (a), (b), and (c) was modified to add a time limit of 45 minutes to the test duration and to make specific that the pass or fail of test specimen would be determined by measuring the vertical char length instead of measuring the percentage of mass loss.
- Step 5 was added back into the Pass/Fail Criteria as the correct numbering of the section was deleted in error.

New - Section 4. Decking Material Test

4.1 Scope:

• This subsection defines the purpose of the decking material test method as it is performed in this section.

4.2 Test Specimen:

• This step incorporates by reference the test specimen procedures found in the ASTM Section 18 steps 18.1 and 18.2.

4.3 Test Procedure:

- The initial instruction incorporates by reference the test procedures of ASTM Section 19 steps 19.1 through 19.6.
- Step 4.3.1 and 4.3.2 specifies the procedures to be taken prior to the beginning of the test.

4.4 Pass/Fail Criteria:

• The steps 1 through 5 specify the basis for the pass or fail determination of the test specimen.

<u>Annex A</u>:

- Note 2 of Annex A and Figure A-1. Draft Enclosure were deleted to remove reference to the draft enclosure from the standard.
- Note 3 was renumbered to Note 2.

Annex B:

- A statement was added to clarify that the Bureau may certify substitutes for the SRM 1196 as it deems appropriate.
- The Standard Polyurethane Substrate specifications were modified and reflect that the specifications are to be based on physical test methods described in ASTM-D3574-08, instead of ASTM-D3574.
- The Sheeting Material section was modified to make grammatical changes relating to the laundering of the sheeting material before its use.
- The Laundering Procedure was added so that consistent washing and drying methods are used.

Annex C:

- Figure C-1 was modified to include additional measurements and to change the order that the measurements are read for consistency.
- The Removable Panel measurements were modified to correct typographical errors.
- Figure C-5 was added to specify the size requirement of the decking material tester.
- Figure C-6 was added to provide an example of the mock-up assembly for the smoldering ignition resistance test.

Precision and Bias:

• This section was added to provide a statistical analysis of the results from the interlaboratory study performed on the standard.

Modified Proposed Language

Amend section 1126 of Article 2 to read as follows:

1126. Official Law Label Requirements.


- (a) Attachment of Law Labels. Labels shall be securely fastened onto completed articles and bulk materials in a manner approved by the Bureau in such an area as to be openly and easily visible to view. Labels are not to be concealed or obstructed from view in any manner.
- (b) Label Material. Law labels shall be constructed of material approved by the Bureau and shall not be easily torn or defaced.
- (c) Color of Label and Color of Ink:
 - (1) A white law label printed in black ink shall be used for new materials.
 - (2) A red law label printed in black ink shall be used for materials which are in whole or in part secondhand (used).
 - (3) A green label printed in black ink shall be used for "Owner's Material."
- (d) Statements and Headings to be Shown on Law Labels:
 - (1) "UNDER PENALTY OF LAW THIS TAG NOT TO BE REMOVED EXCEPT BY THE CONSUMER" shall appear at the top of the label.
 - (2) Headings shall read "All New Material" when the material is wholly new; "Secondhand (Used) Material" when the material is in whole or in part secondhand.
 - (3) Description of filling material as provided in the applicable regulations.
 - (4) For owner's own materials the heading shall state: "THIS ARTICLE NOT FOR SALE" "OWNER'S MATERIAL."
 - (5) The registry number assigned or approved by the Bureau.
 - (6) "Certification is made by the manufacturer that the materials in this article are described in accordance with law."
 - (7) For owner's own materials the certification portion of the label shall state: "CERTIFICATION IS MADE THAT THIS ARTICLE CONTAINS THE SAME MATERIAL IT DID WHEN RECEIVED FROM THE OWNER AND THAT ADDED MATERIALS ARE DESCRIBED IN ACCORDANCE WITH LAW AND CONSIST OF THE FOLLOWING."
 - (8) For owner's own materials the name and address of the owner.
 - (9) The finished size of articles of bedding such as sleeping bags, mattresses, comforters, mattress pads, pads, box springs, pillows, and similar articles, showing the width and length expressed in inches. Decorator pillows need not show size.
 - (10) The net weight of filling materials in articles of bedding such as sleeping bags, mattresses, box springs, pads and similar items, stated in pounds and ounces.
 - (11) All bulk filling materials which meet the requirements of Bureau of <u>Electronic and</u> <u>Appliance Repair</u>, Home Furnishings <u>and Thermal Insulation</u> Technical Bulletin No.

117<u>-2013</u>, dated March 2000 January June 2013 shall have imprinted on the law label immediately following the requirements as set forth in subsection (c) of this section the statement: "THIS PRODUCT MEETS THE REQUIREMENTS OF BUREAU OF <u>ELECTRONIC AND APPLIANCE REPAIR</u>, HOME FURNISHINGS <u>AND THERMAL INSULATION</u> TECHNICAL BULLETIN 117<u>-2013</u>."

- (12) In addition to the requirements set forth in subsection (11) of this section all invoices for products meeting the requirements of Bureau of <u>Electronic and Appliance</u> <u>Repair</u>, Home Furnishings <u>and Thermal Insulation</u> Technical Bulletin No. 117<u>-2013</u>, dated <u>March 2000 January June 2013</u> shall have stated on such invoices the identification of the product meeting the requirement and the statement that such identified products meet the requirements of Bureau of <u>Electronic and Appliance</u> <u>Repair</u>, Home Furnishings <u>and Thermal Insulation</u> Technical Bulletin No. 117<u>-2013</u>.
- (e) Size of Law Labels and Type of Printing:
 - (1) The minimum size of labels shall be 2 x 3 inches. Labels shall be larger when the required size of type and statements make it necessary.
 - (2) The minimum size of type shall be one-eighth inch in height, in capital letters.
 - (3) All printing shall be in English.
- (f) Forms of Law Labels.

Repeal section 1370 of Article 13 as follows:

1370. Fire Resistant, Flame Resistant, Flame Retardant.

- (a) On and after July 1, 2014, Ffilling materials and cover fabrics labeled as <u>"fire resistant,"</u> "flame resistant," "flame retardant" and words of similar import shall be tested in accordance with, and shall meet the requirements of, the State of California, Bureau of <u>Electronic and Appliance Repair</u>, Home Furnishings <u>and Thermal Insulation</u> Technical Bulletin No. 117<u>2013</u>, entitled "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance <u>Smolder Resistance</u> of Filling Materials Used in Upholstered Furniture," dated March 2000 January 2013 which is incorporated by reference. This section shall not apply to articles of furniture manufactured prior to July 1, 2014.
- (b) Fabrics labeled as "flame resistant," "flame retardant," and words of similar import shall be tested in accordance with, and shall meet the requirements of, the State of California, Bureau of Home Furnishings Technical Bulletin No. 105, entitled, "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance of Fabrics," dated January 1980.

Amend Section 1373.2 of Article 13 to read as follows:

1373.2. Flammability; Flexible Polyurethane Foam.

<u>On and after July 1, 2014 January 1, 2015</u>, Aall flexible polyurethane foam in the form of slabs, blocks, or sheets, or which is shredded (loose or packaged), except polyurethane foam which cannot reasonably be expected to be used in or as an article of furniture or in or as a mattress, that is offered for sale to the general public at retail outlets in this state for non-commercial or non-manufacturing purposes shall meet the test <u>fire retardant</u> requirements set forth in Section A, Part I; Section A, Part II and Section D, Part II Section 3, Resilient Filling Material Test of the State of California, Bureau of <u>Electronic and Appliance Repair</u>, Home Furnishings <u>and Thermal Insulation</u> Technical Bulletin No. 117-2013, entitled "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance <u>Smolder Resistance</u> of Filling Materials Used in Upholstered Furniture," dated March 2000 January June 2013 which is incorporated by <u>reference</u>. This section shall not apply to flexible polyurethane foam manufactured prior to July <u>1, 2014 January 1, 2015</u>.

Amend section 1374 of Article 13 to read as follows:

1374. Flammability; Upholstered and Reupholstered Furniture.

- (a) On and after July 1, 2014 January 1, 2015, Aall filling materials and cover fabrics contained in any article of upholstered furniture, and all filling materials added to reupholstered furniture, shall meet the test fire retardant requirements as set forth in the State of California, Bureau of Electronic and Appliance Repair, Home Furnishings and Thermal Insulation Technical Bulletin Number 117-2013, entitled "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance Smolder Resistance of Filling Materials Used in Upholstered Furniture," dated March 2000 January-June 2013 and be labeled in accordance with Section 1374.3. This section shall not apply to filling materials and cover fabric manufactured prior to July 1, 2014 January 1, 2015.
- (b) In addition to the requirements of subsection (a) above, finished articles of upholstered furniture may also be tested in accordance with the State of California, Bureau of Home Furnishings Technical Bulletin Number 116 entitled "Test Procedures and Apparatus for Testing the Flame Retardance of Upholstered Furniture," dated January 1980.
- (c) On and after March 1, 1992, a<u>A</u>ll upholstered seating furniture sold for use in public occupancies, as defined in subsection (d) below, shall meet the test requirements set forth in the State of California, Bureau of Home Furnishings and Thermal Insulation Technical Bulletin Number 133, entitled "Flammability Test Procedure For Seating Furniture For Use in Public Occupancies," dated January 1991.
- (d) For purposes of this section, the term "public occupancies" shall mean:
 - (1) Jails, prisons, and penal institutions, as defined in Chapter 3 of the California State Building Standards Code.
 - (2) Hospitals, mental health facilities, and similar health care facilities, as defined in Chapter 3 of the California State Building Standards Code.
 - (3) Nursing homes, board and care facilities, and convalescent homes, as defined in Chapter 3 of the California State Building Standards Code.

- (4) Child day care centers, as defined in Chapter 3 of the California State Building Standards Code.
- (5) Public auditoriums and stadiums, as defined in Chapter 3 of the California State Building Standards Code.
- (6) Public assembly areas, as defined in Chapter 3 of the California State Building Standards Code, containing ten (10) or more articles of seating furniture and located in hotels, motels and lodging houses.
- (e) Public occupancies and public assembly areas, as defined in section 1374(d), which are fully sprinklered in accordance with either National Fire Protection Association (NFPA) Standard NFPA 13-1996 or Uniform Building Code Standard No. 38-1, dated 1988 shall <u>either</u> comply with the requirements of section 1374(a) and may comply with <u>or</u> the requirements of section 1374(c).
- (f) The flammability requirements contained in this section are considered to be flammability performance standards. Testing under these standards shall be at the discretion of the licensee; however, products and materials offered for sale in this state shall meet all applicable flammability requirements established in these regulations.

Amend section 1374.2 of Article 13 to read as follows:

1374.2. Criteria for Exemption.

Articles of upholstered furniture, other than furniture used for and in facilities designed for the care or treatment of humans, which meet any of the following criteria shall be exempt from compliance with the provisions of Section 19161 of the Home Furnishings Act:

- (a) Cushions and pads intended solely for outdoor use.
- (b) Any article which is smooth surfaced and contains no more than one-half (1/2) inch of filling material, provided that such article does not have a horizontal surface meeting a vertical surface.
- (c) Strollers, infant carriers, and nursing pillows <u>Bassinets</u>, booster seats, car seats, changing pads, floor play mats, highchairs, highchair pads, infant bouncers, infant carriers, infant mattresses, infant mattress pads, infant seats, infant swings, infant walkers, nursing pads, nursing pillows, playpen side pads, playards, portable hook-on chairs, and strollers.
- (d) Any article manufactured in accordance with a written prescription from any one of the health care professionals set forth in this subdivision, or manufactured in accordance with other comparable written medical therapeutic specification, to be used in connection with the treatment or management of a named individual's physical illness or injury. Any one of the following health care professionals may provide the written prescription required by this subdivision provided that the health care professional has a current and valid license to practice in California or any other state of the United States in which the prescription was written: physicians, chiropractors or osteopaths.

1383.2. Fines.
